Michigan State University (“MSU”) was founded in 1855 as the nation’s first land-grant university. Since then, it has grown into a comprehensive research university with about 5,900 faculty and academic staff, 7,800 support staff, 40,483 undergraduate, and 10,833 graduate and professional students. The total enrollment of more than 51,300 is the largest single campus student body of any Michigan university and among the largest in the country. MSU has more than 400 programs of study offered by 17 degree-granting colleges and an affiliated law college.
